## 4.2 Quality and importance

Àrea de relleu alomado constituïda per un mosaic de vegetació natural, cultius de secà i cultius de regadiu, drenat per una interessant xarxa de ramblas i barrancs. Situada en un contexte marcadament semiàrid, les formacions vegetals alberguen magnífics pins naturals de pi carrasco (*Pinus halepensis*), acompanyats per un coscocar amb lestisc i palmit en bon estat de conservació. També cal destacar els tomillars i els prats anuals, rics en espècies endèmiques i d'interès, com *Bupleurum gibraltàricum*, *Teucrium carolipau*, *Helianthemum almeriense*, *Helianthemum caput-felis*, *Thymus moroderi*, *Thymus hyemalis*, etc. Els cursos de rius i ramblas alberguen també formacions destacables, com els tarayars. En quant a les espècies, cal destacar per la seva importància la població de *Hieracium fasciatum* -y, en menor grau, de *Aquila chrysaetos*, que tenen en aquesta zona la més important àrea de dispersió valenciana dels exemplars inmadurs.
